## THE COLONIAL RESTAURANT “HOT CURRY CHALLENGE”

### 1. RULES & WAIVER OF LIABILITY

Challenge is open to all Australian residents 18 years or older. Employees of RGC Restaurants Pty Ltd T/A (The Colonial Restaurants) are not eligible to enter. Herein we refer to / interpret as; RGC Restaurants Pty Ltd T/A The Colonial Restaurants as “The Colonial” and Hot Curry, Meal, Dish, Bowl, Main Course, Food as “Hot Curry”

### 2. TO ENTER:

**CAREFULLY READ THESE OFFICIAL CHALLENGE RULES AND ENTRY FORM FOR THE COLONIAL HOT CURRY CHALLENGE INCLUDING THE ELIGIBILITY REQUIREMENTS AND WAIVER OF LIABILITY PROVISIONS.** Complete and sign this document. All entry forms, videos and photos arising from, or in conjunction with the challenge become the property of RGC Restaurants Pty Ltd T/A (The Colonial Restaurants).

### 3. CHALLENGE RULES:

- a) All validated contestants will have one entry and twenty (20) minutes to consume, in full, a standard main course sized serve of exclusive Hot (Chili and Spicy) Curry prepared by The Colonial Restaurants.
- b) Entry is made by booking in advance a table at either restaurant location on a Monday, Tuesday or Wednesday (excluding public holidays or days where the restaurant may be closed for any planned or unplanned reason).
- c) Entries are available at the following restaurant locations;
  - 1) The Colonial Restaurant (118 Crown Street, Darlinghurst) **5pm to 10pm on Monday, Tuesday, Wednesday**
  - 2) The Colonial Restaurant (19 Grosvenor Street, Neutral Bay) **5pm to 10pm on Monday, Tuesday, Wednesday**
- d) Contestants must remain seated during the challenge from the time it commences for twenty (20) minutes and then a further five (5) minutes after the meal is consumed in full.
- e) Lip balm, napkins, bathroom/toilet breaks, drinks, gloves, breads or otherwise will not be permitted during the challenge.
- f) Only one stainless steel (metal) spoon or fork or knife will be provided; at the choice of the contestant.
- g) The Colonial reserves the right to disqualify any contestant it deems unfit to participate without explanation. Their decision is final and will not be negotiated.
- h) A contestant must completely eat the Hot Curry in full leaving nothing behind but mere smudges of the remains of the Hot Curry.
- i) A contestant must wait for the starting signal to begin eating and may not touch the Hot Curry prior to the starting signal.
- j) A contestant must stop eating and must promptly place their hands down on the table or at their side at the twenty (20) minute mark deemed by the stop watch.
- k) A contestant may not put any additional Hot Curry in their mouth after the ending signal, but will be allowed 15 seconds to swallow any food already in their mouth. If a contestant regurgitates, he or she will be disqualified.
- l) Judges will be on hand to assure adherence to contest rules and to disqualify a contestant who fails to adhere to the rules. Grounds for disqualification include:
  - 1) False or incomplete entry form or liability waiver
  - 2) Any health risks that could jeopardize the contestant’s health or well being
  - 3) Under the influence of any substance
  - 4) Appearance is deemed inappropriate by The Colonial staff
  - 5) Starting prior to the start signal
  - 6) Continuing to eat after the ending signal
  - 7) Failure to completely eating the hot curry in full
  - 8) Regurgitating
- m) If you are disqualified or do not complete the challenge, the Hot Curry will be charged at the price of \$15.00 AUD and will be payable to The Colonial Restaurants as part of your lunch or dining bill at the end of your challenge or at time of departure.
- n) Winners will be determined by:
  - 1) Eating the entire bowl of Hot Curry served to them in the allotted twenty (20) minute timeframe.
  - 2) Remaining seated for an additional five (5) minutes after the ending signal is announced.

#### 4. PRIZE AWARDS:

Prizes will be awarded as follows; the contestant who eats the entire bowl of Hot Curry within the allotted time of twenty (20) minutes will receive:

- a) The Hot Curry will be supplied free of charge
- b) A drink (glass of wine, bottle of beer or glass of soft drink, juice or bottled water and/or glass of full cream milk) will be supplied free of charge after the challenge has concluded and upon being announced as a winner
- c) The Colonial Restaurant Prize Pack including;
  - a. \$20 next visit voucher
  - b. Editorial to be posted via The Colonial Restaurants digital and print mediums including social platforms
- d) Bragging rights as the 'The Colonial Hot Curry Challenge Winner'
- e) All participants agree to the use of photos, videos, editorials and their name, voice, likeness, and city/town/village for advertising or trade purposes and to cooperate reasonably in any effort to promote or publicise The Colonial Hot Curry Challenge.
- f) Apart from the prizes associated with being selected as a winner, The Colonial Restaurants shall not be obligated to compensate you in any way for such publicity.
